



#### **ABOUT SUSTAINABILITY VICTORIA**

Sustainability Victoria is a Victorian Government agency with a statutory objective to facilitate and promote environmental sustainability in the use of resources.

We are all about information, advice and support to tackle climate change and use our precious resources wisely. We work with individuals, households, schools, communities, businesses and local authorities to embrace sustainable practices. We fund great ideas and help bring them to life. We explore creative solutions and show they can work. We connect great minds. But there is still a lot of work to do.

Victoria's population growth continues to be the fastest in Australia. Our challenge is to manage this growth so that public amenity and health is maintained and improved. The waste and resource recovery sector is fundamental to doing so and SV seeks to address a range of challenges to realise the full economic value of resource recovery opportunities.

#### **ROLE IN BATTERY STEWARDSHIP**

SV is involved in product stewardship initiatives for a range of priority products and materials, engaging broadly across community, industry, academia, local, state and federal governments. SV are active members of ABRI and have supported national efforts to establish a product stewardship approach for batteries in Australia since 2013.

SV also established the "Batteryback" program in Victoria until it was novated to ABRI in 2015. SV has also managed Victoria's "Detox Your Home" program since it was established in 1994. This program provides Victorian households with free access to safe disposal points for end-of-life handheld batteries and other highly toxic, unwanted household chemicals in collaboration with local Victorian councils.

#### **HISTORY**

SV has a long history supporting several national product stewardship approaches and waste and resource recovery programs for various priority materials, including e-waste, paint and tyres.

These programs have all been successful in providing a clear picture of the barriers and opportunities for each waste stream, assisting to identify evidence, and trial systems that efficiently cost and recover priority products. SV has also worked to inform policy and regulatory options and provide evidence for potential stewardship interventions.

SV (on behalf of the Victorian Government, with support from all states and territories) are presently leading research to assess national stewardship approaches for end-of-life PV systems, through more guided and responsible product design, recovery and treatment.

#### **COMMITMENT TO SUSTAINABILITY**

Victoria's waste and resource recovery sector contributes over \$4 billion to our state's economy and employs over 12,000 people. It also manages the environmental impact of waste and helps our communities to maintain and improve their quality of life.

To support a thriving waste and resource recovery sector, Victoria is moving towards a circular economy - where materials are kept circulating within the economy at their greatest value for as long as possible.

Creating a circular economy in Victoria will create a future of wellbeing, vitality and prosperity to ensure we are the most sustainable state in Australia by 2030.

Sustainability Victoria has been thinking circular for a number of years. We are advocates of circular economy and we apply the principles in our program design and delivery.

We understand circular economy is complex and requires commitment from industry, government and the community.

We encourage all Victorians to:

- Rethink the way we extract, produce, consume and manage our resources
- Recover products and extract high-value materials from these goods
- Reuse products and materials, purchase and lease recovered and reusable products.
