Earlier this month the Battery Stewardship Council, of which ABRI is a founding member, submitted its application to the ACCC for authorisations necessary for the establishment of a national battery stewardship Scheme. It was anticipated that this Scheme would commence early in the new financial year, however the response to COVID-19 has potentially impacting on proposed implementation.
